## Dear President Biden:

Thank you for your commitment to protect and restore our nation's most special and vulnerable places for the benefit of all people today and for generations to come. Today is the fifth anniversary of the creation of the Northeast Canyons and Seamounts Marine National Monument on September 15, 2016. Recent events have only underscored the importance of the area and the need for its protection. The 61 undersigned organizations are writing to urge you to restore full protections for this incredible area, as well as Bear Ears and Grand Staircase-Escalante.

The Northeast Canyons and Seamounts – the first marine national monument in the U.S. Atlantic Ocean – protects unique species and habitats, valuable ecological resources, and the fragile ocean ecosystem against adverse human activities. This summer, NOAA's *Okeanos Explorer* deployed a remotely operated vehicle in the monument on one of the summits of the multi-peaked Retriever Seamount. The dive revealed "a dense, high-biomass, high-diversity coral garden" that impressed all of the scientists. A notably large colony of bamboo coral, referred to as a "land of the giants" by one of the scientists, is estimated to be approximately 1,600 years old.

In July, the New England Aquarium conducted <u>an aerial survey</u> of the monument's canyons unit that spotted truly amazing ocean wildlife and gathered observations that deepen scientific knowledge of the area. The survey – the 11<sup>th</sup> in a series since the monument was established – observed a sperm whale, whale shark, pilot whales, ocean sunfish, and four different species of dolphin. A common theme was seeing mother calf pairs and animals that depend on squid for their diet.

The Northeast Canyons and Seamounts Marine National Monument is an underwater treasure – for the American public, for scientific discovery, and for the incredible ocean wildlife it supports. Last year, President Trump stripped the monument's protections and allowed commercial fishing in this protected area, <u>reducing species protection</u>. The monument and the refuge it provides for endangered whales, centuries-old deep-sea corals, fish, and seabirds were immediately put at risk.

More than 200 days have passed since Executive Order 13990 was signed. Since then, Secretary Haaland reportedly has recommended fully restoring protections to the Northeast Canyons and Seamounts (as well as Bears Ears and Grand Staircase-Escalante). We urge you to heed the Secretary's recommendation to restore full protection to the Northeast Canyons and Seamounts Marine National Monument and erase the legacy of the illegal, unfounded rollbacks by President Trump.
